JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Techy Jenny on 06.04.2023 filed an RTI application in Form-A to the PIO-cum-PD DRDA Yupia, Papum Pare District, Arunachal Pradesh, whereby, seeking various information as quoted in Form-A application.

Appellant being not fully furnished with the information from the PIO, filed the First Appeal before the First Appellate Authority on 24.05.2023. Appellant again having not received the required information from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 26.06.2023 and Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No. 591/2023 and processed the same for its hearing and disposal.

Accordingly, this matter came up before the Commission for 5th hearing today on 07.06.2024. In this final hearing of the appeal on 07.06.2024 the PIO-Cum-PD

DRDA Yupia, Papum Pare District found absent and the appellant also absent during the hearing. On perusal of the case file records it is observed as follows:

First hearing took place on 15.09.2023 in which the PIO was represented by Shri Tarh Taming APO (RE) and appellant Shri Techy Jenny was present. Order passed for furnishing of information in full shape within one week.

Second hearing took place on 24.11.2023 in which the PIO Smt. Bengia Yakar, PD was present but the appellant found absent. In this hearing the PIO submits that additional and full information was furnished to the appellant dated 20.09.2023 and the same was received by appellant. A copy of this intimation is received in commission.

Third hearing took place on 25.01.2024 in which the PIO was present and the appellant found again absent. The PIO reiterated that information was already received by the appellant.

Forth hearing took place on 08.04.2024, both PIO and appellant did not appear. It was observed that the appellant remained absent in the last three consecutive hearings on 24.11.2023, 25.01.2024 and 08.04.2024. It was ordered that in case the appellant does not attend next hearing the case shall be disposed of assuming that the appellant has already received the information to his satisfaction.

Notice of hearing dated 12.04.2024 was issued well in advance to the PIO and Appellant for today's 07.06.2024 hearing. Both Appellant and PIO remained absent. The Appellant remained absent for last four consecutive hearings. It is assumed that the Appellant has received the information to his satisfaction. Further hearing entails wastage of this commission court's time.

In view of the above facts and circumstances I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
