Shri Lebe Namnio -V/S- PIO-cum- DAH & VO District , Govt. of Arunachal Pradesh.

ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Lebe Lamnio on 17/08/2023 filed an RTI application under Form-'A' before the PIO-Cum-District AH & Veterinary Officer Seppa under East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 18.09.2023 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08.12.2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 198/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 13/06/2024 & 08/08/2024, this hearing of the appeal on 8th day of August 2024. The PIO present during the hearing and Appellant Shri lebe Lamnio absent during the hearing without intimating to the Commission for his inability to attend the hearing of the appeal.

The PIO has stated before the Commission that as per the order passed in last hearing by this Court on dated 13th June 2024 all the information sought by the Appellant are properly addressed and furnished to the Appellant through post office vide registered no. RE406188804IN dated 18.06.2024. and the same letter was receipt by his sister namely Smti/Miss Karte Cheda from the post master.

After hearing the PIO and looking the evidence produced by the PIO before the Commission during the hearing the Commission completely.

Therefore, on the above facts and circumstance I find this appeal fit to be disposed and closed. And accordingly, this appeal stands disposed and closed once for all.
