#### ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Chow Tasina Namchoom, Vill-Manfaiseng, PO-Nanam Shyam-1, PS-Namsai, District Namsai, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P., Bordumsa Division, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/06/2023 regarding Details of all the relevant information regarding execution of Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) at Bordumsa Circle.

Whereas the 5<sup>th</sup> hearing held today on 15<sup>th</sup> October' 2024 (Tuesday) at 1030 hrs. Shri Misa Gamlin, PIO-Cum- BDO, Bordumsa Division Changlang, Changlang District, A.P. and Shri Chow Tasina Namchoom, Appellant both the parties were present the court hearing through hybrid mode.

The Appellant informed that as per the direction of the Commission on 4<sup>th</sup> hearing held on 30<sup>th</sup> July' 2024 (Tuesday), he had received the Sl. K. and Sl. No. L was yet to be furnished by the PIO. The PIO in his defence stated that there were some problems on taking Geo tag due to non-completion of the project work. However, after completion of the project work, the CTC documents have been furnished to the Appellant on 16<sup>th</sup> August' 2024.

The Commission observed that since the required information had been provided to the Appellant by the PIO on 16<sup>th</sup> August' 2024 as per the direction of the court, the matter is treated as closed.

Hence, the case is disposed of and closed.
