**a) Information requested:**

Furnish all relevant documents which pertaining to the Office of Deputy Commissioner (DC) Likabali Lower Siang District AP.

1. Furnish copy of phase wise sanctioned orders received from NHPC from 2001 to till 2022.

2. **(A)** Furnish the details area (ha) and total assessment bills amount of each Community Land, pertaining to compensation made as per judgment dated 09.02.2020 Of the Hon'ble High Court, Itanagar bench SLP(C) No.6856/2020 and order date 31.02.2022 in SLP(C) no(s) 23502351/2021 by Hon'ble Supreme Court of India. Which Amounting of Rs.27, 75, 36,359 (Twenty seven crore seventy five lakhs thirty six thousand three hundred fifty nine only) private community/clans land of PAFs with community land 124.15ha from adjoining area having land under forest cover including the values of land, trees, bamboo and tokopatta coming under the submergence area of 122sha, West Siang district (AP) i.e (i) Gengi village community land. (ii) Siberite village community land (iii) Doje Settlers kena clan, hale, hai community land (iv) Ditten Village community land. (v) Tango village community and (vi) Sibe village community land (vii) Ossumpum Village community land. (viii) Lutak village community land.(ix) Dibe village community land. (x) Durpai village community land (xi) Teyidu village community land.

**(B)** Furnish details copy of 3 instalment money receipt/ counter foil of PAFs beneficiaries of Sebrite, Gangi village community land having under forest cover.

**(C)** Furnish details copy of 3 instalment money receipt/ counter foil OF PAFs beneficiaries of Sebrite, Gangi village community land having under without forest cover.

**(D)** Furnish the details area (ha) and total assessment bills amount of each Community Land, and furnish the details Geo Tag with Maps pertaining to compensation made as per judgment dated 09.02.2020 Of the Hon'ble High Court, Itanagar bench SLP(C) No.6856/2020 and order date 31.02.2022 in SLP(C) no(s) 2350-2351/2021 by Hon'ble Supreme Court of India. Which Amounting of Rs.27,75,36,359 (Twenty-seven crore seventy-five lakhs thirty-six thousand three hundred fifty-nine only) private community /clan land of PAFs with community land / clans 540ha from adjoining area having land without forest cover i.e. land in the bank of river including shoal area coming under submergence area of 1225ha in West Siang (ap) i.e. (i)community land of Gangi village (ii) community land of Siberte village (iii) community land of Rimen village (iv) Gachi clan community land (v) doje settlers community land.

3. Furnish the list of total actual affected families comes under community land of each villages i,e (1) adjoining area having without forest cover i.e. the bank of river including shoal area and (2) adjoining area having forest cover i.e. land, trees ,bamboo and tokopatta etc.

4. Furnish the payment details/ A —Roll book with duly signed by each beneficiary with revenue stamp, as per bills measurement prepared by competent authority along with their counter signed.

5. Furnish details plot wise Sketch Maps, Geo Tag reports and photograph of private community/clans land of PAFs with community land fall under 1225ha
6. It is come to know that, the community land compensation amount has been deposited in some selected individual account number by your good office, if so, then furnish the authorization Letter made between community land beneficiaries and authorized person and also furnish the minutes of the meeting/resolution in this regard.
7. Furnish the constituted board committee report of vide order No. DC /LSD/NHPC-01/2018, Dated Likabalai, the 31<sup>st</sup> May 2022. Regarding finalizing of actual beneficiaries under community land of each village to disbursement of compensation amount respectively.
8. Furnish details counter foil of each beneficiary and furnish segregate counter foil of community land compensation amount and 29 project affected individual beneficiaries.
9. Furnish details segregate assessment reports and total bills amount of 10 community land.
10. Furnish details assessment reports and total bills amount of project affected individual beneficiaries.
11. Furnish all related documents if available pertaining in this project.
12. All documents must be certified true copies & annexure.

Hearing adjourned. Next date of hearing shall be fixed on receipt of compliance report of this order from Appellant and PIO. In default of it the appeal shall be closed and dispose of without further hearing.
