**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Techi Jeeny on **04/12/2023** filed an RTI application in Form- 'A' before the PIO-cum-PD, District Rural Development Agency (DRDA), Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' applicant. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **15/02/2024**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **01/05/2024** and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC No- 188/2024 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearings before the Commission, for 3 (three) consecutive times on 18/06/2024, 30.07.2024 and 26.11.2024. In the final hearing of the appeal the Appellant Shri Nabam Tai, present in person. The PIO is represented by Shri H.A. Opo, Range Forest Officer (RFO) Medo Forest Range, Govt. of Arunachal Pradesh.

Heard the Appellant and the APIO:

The APIO stated that all the information(s) sought by the Appellant are already furnished to the Appellant. The Appellant informed the Commission that he in receipt of the information(s) and requested the Commission for disposal of this appeal with liberty to file fresh application for further need of the information(s), if any.

The Commission allow the prayer of the Appellant to dispose this appeal with liberty to the Appellant, for filing fresh application, in need for the same information(s).

In view of the above facts and circumstances the Commission finds this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed of and closed once for all.
