## JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Lokam Namdu on **05.07.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Hydro Power), Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **11.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 877/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 23.0.2024. In this hearing of the appeal on 23<sup>rd</sup> day of September, 2024, the appellant Shri Lokam Namdu but the PIO-cum-Executive Engineer (Hydro Power), Koloriang Division, Kurung Kumey District found absent without any information to the Commission. The appellant is directed to file before the F.A.A for the information under Section 6 of RTI Act which he is seeking. The FAA-cum-Chief Engineer (Hydro Power), Western Zone, Itanagar, Govt. of Arunachal Pradesh and PIO-cum-Executive Engineer (Hydro Power), Koloriang Division is directed to take up case and dispose as per Section-7 of RTI Act, 2005 within 30 days on receipt of the request.

Under Section 19(1) of the Act, the First Appellate Authority (FAA), the intermediate level, has to adjudicate on the Appeal, if any, filed by the information seekers against the decision of the PIO.

As laid down at para-38 of the Guidelines for the FAA issued by the GOI and the State Govt., adjudication on the appeals under the RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.

The First Appellate Authority (FAA), following the principle of natural justice, should conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter must pass reasoned and speaking order on merit within 30 days from the date of receipt of the appeal or else the action of the FAA would be considered as procedural lapse on the part of the FAA.

Further, it is noticed that the Appellant in most case do not wait for the orders of the First Appellate Authority (FAA) and directly prefer appeals before the 2<sup>nd</sup> Appellate Authority without attaching a copy of order passed by the First Appellate Authority (FAA) unintelligently. Here, it is germane to note that for availing 2<sup>nd</sup> appeal before the 2<sup>nd</sup> Appellate Authority, the Appellant has been given 90 days' time from the date of order passed by the First Appellate Authority (FAA). The 2<sup>nd</sup> appeal, if he/she is dissatisfied with the decision of the First Appellate Authority (FAA), must be accompanied by the orders passed by the First Appellate Authority (FAA).

Therefore, perusing the case records, the Commission deemed fit to remand back he appeal case APIC No. 877/2023 to First Appellate Authority for proper hearing. The case is disposed off with liberty to appellant to prefer second appeal if dissatisfied or aggrieved by the decision of the First Appellate Authority for which no fees need be paid.
