An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-154/2024

## ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Lebe Lamnio on 28.12.2023 filed an RTI application under Form-'A' before the PIO-Cum- EAC, O/o the Deputy Commissioner, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 06.02.2024 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 22.03.2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 154/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thrice i.e on 21.05.2024, 02.07.2024 & 22.08.2024. In this hearing of the appeal on 22<sup>nd</sup> day of August, 2024. The Appellant Shri Lebe Lamnio and the PIO found absent during the hearing.

However, the Appellant has submitted a letter to the Commission through whatsapp on dated 22/08/2024 that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
