Relevant facts emerging from appeal:

The following were present: -

RTI application filed on : 25.08.2024
SPIO replied on : 29.09.2024
First appeal filed on : 28.11.2024
First Appellate Authority's Order : 23.12.2024
Second Appeal filed on : 31.12.2024

The appellant filed an RTI application dated 25.08.2024 seeking following information pertaining to implementation of fund receipts for 12% free power supply of home state and 1 % Local Area Development /Projects in the states of Arunachal Pradesh from 2008 to till date.

## **Detailed of information required:**

- i) Copies of the money receipts/deposits records, including cheques, RTGS/NEFT, PFMS (PPA), deposit slips and any other methods of deposits/payment for 12% free power supply of home state and 1 % Local Area Development funds by the Hydro Power Developers/ Corporations.
- ii) Sanction order copies issued out of the funds received for 12% free power supply of home state and 1 % Local Area Development fund (LADF), if any.
- iii) Details of release/transfer/payment of funds receipts for 12% free power supply of home state and 1 % Local Area Development fund (LADF) with copies of cheques, RTGS/NEFT/PFMS (PPA), hand receipts and any other mode of payment/release/transfer, if any.
- iv) Copy of MOU/MOA for Ranganadi Hydro power project.

Periods: 2008 to till date.

The following were present.

Appellant : Absent

Respondent PIO : Present. He states that information sought under

serial no (i) in the RTI application has been furnished

with explanation.

## **Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the PIO has furnished information pertaining to serial no. (i) in RTI application form – A to the applicant. The FAA – the Chief Engineer (Commercial) has heard the appellant and the PIO on 23.12.2024. He has explained the pertaining information in length including furnishing the calculation sheet of LADF amount to the appellant and closed the appeal. The appellant has filed 2<sup>nd</sup> appeal to this commission on 31.12.2024 for the reason of incorrect and misleading information. However, the appellant was not present in the hearing today to substantiate his claim. The appellant is directed to file written submission to the PIO specifying how the information furnished / explain to him by the FAA and PIO within ten days from the date of issue of this order under intimation to this commission. Upon receipt of such written submission the PIO shall clarify the matter to the applicant within a period of one week.

In case no compliance report of this order is received from the appellant and PIO within a period of 15 days i.e. on or before 06.06.2025, this appeal case shall be closed and disposed of without further notice and hearing.
