JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dugi Sakam & Bomrik Taity on **08.02.2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (WRD), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **22.03.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.05.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 381/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 8 (eight) time i.e on **26/06/2023, 07/08/2023, 25,09/2023, 16/10/2023, 04/12/2023, 22/01/2024, 08/04/2024 and 12/06/2024**. In this hearing of the appeal on 12th day of June, 2024, PIO present and appellant found absent without any information to the Commission. Since, the appellant was absent repeatedly for 3 (three) occasion dated 22/01/2024, 08/04/2024 and 12/06/2024 inspite of giving **Last Warning Summon Notice**. It seems that the appellant is not interested for pursuing the information further.

In view of the above facts and circumstances, I find this appeal fit to be disposed off in absence of the appellant. And, accordingly, this appeal stands disposed off and closed once for all.
