#### ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri G.F. Rimo, Papu-II, Near Govt. Pry. School, Papu Village, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/07/2023 regarding Compensation of Power Grid Cooperation of India pvt ltd Construction of 132 KV transmission line, Nichipu to Palizi and Palizi to Trizino.

2). The 5<sup>th</sup> hearing was held on 3<sup>rd</sup> December, 2024 as scheduled. Dr. Marchina Boria, the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh and the Appellant Shri G.F. Rimo were present.
