ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri G.F. Rimo, Papu-II, Near Govt. Pry. School, Papu Village, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/07/2023 regarding Compensation of Power Grid Cooperation of India pvt ltd Construction of 132 KV transmission line, Nichipu to Palizi and Palizi to Trizino.

2). The 5th hearing was held on 3rd December, 2024 as scheduled. Dr. Marchina Boria, the PIO-cum-ADC, Thrizino, West Kameng District, Arunachal Pradesh and the Appellant Shri G.F. Rimo were present.
