JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Ram Rimo & Rampung Lamgo on 06/02/2023 filed an RTI application under Form-'A' before the PIO, Office of the Directorate of Elementary Education, Govt. of Arunachal Pradesh, Itanagar whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 22/03/2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 04/08/2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 732/2023 & 737/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (Four) times i.e. on 21.12.2023, 02.02.2024, 13.03.2024 & 03.06.2024.** In this hearing of the appeal on **3rd day of June, 2024,** the PIO-cum-Executive Engineer (RWD), Office of the Chief Engineer (Coord), Itanagar present but appellant Shri Ram Rimo & Rampung Lamgo found absent without any intimation to the Commission.

In the order dated 21/12/2023, the PIO has intimated to the Commission that he has brought with him all the information as sought by the appellant in his form 'A' application to hand over to him. But due to absence of the appellant the PIO could not be handed over the information to the appellant. On this, the appellant was issued summon notice to appear in person before the Commission in the next date of hearing but he failed to comply the direction of the Commission. The appellant remained absent consecutively 4 (four) hearing on **dated 21.12.2023, 02.02.2024, 13.03.2024 & 03.06.2024.** So, it is deemed that the appellant is no more interest on this case Appeal No. APIC-732/2023 & 737/2023.
