**Information sought :**

The appellant file a RTI Application dated 10/05/2023 seeking Details regarding Land allotment certificate issued for Upper Colony area, Likabali and Land Possession Certificate issued for areas under Richi Rite Village, Kangku Circle.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 07/07/2023. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mikre Taso on **10.05.2023** filed an RTI application under Form-'A' before the PIO-cum-DLRSO, Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07.07.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 866/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 12 (twelve) time i.e on 13/11/2023, 11/12/2023, 29/01/2024, 29/04/2024, 17/06/2024, 12/08/2024, 09/09/2024, 11/11/2024, 10/02/2025, 24/03/2025, 26/05/2025 and 11/08/2025. In this hearing of the appeal on 11<sup>th</sup> day of August, 2025, both the parties, the PIO-cum-DLRSO, Likabali, Lower Siang District and the appellant Shri Mikre Taso present in person.

As per the case record, the penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only was imposed against the PIO on 11<sup>th</sup> hearing dated 26/5/2025. The PIO has deposited the penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only through Treasury Challan and submitted a copy of the same to Commission on 11/8/2025 12<sup>th</sup> hearing. The PIO has also submitted an Affidavit Declaration stating the reasons for his non-appearance on the last hearing dated 26/05/2025.

The appellant has submitted a letter addressed to the Commission stating that all the information as sought has already been provided by the PIO and he is satisfied by the information provided and he requested for disposing of the appeal case.

Request accepted and the appeal case No.APIC-866/2023 is disposed of and closed.


