JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tongam Jamoh on **03/04/2023** filed an RTI application under Form-‘A’ before the PIO-cum-Assistant Conservator of Forest, Office of the Chief Conservator of Forest, Eastern Arunachal Circle, Tezu, Lohit District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13/05/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16/06/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 556/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7 (seven) times i.e on 16/10/2023, 04/12/2023, 22/01/2024, 08/04/2024, 10/06/2024, 29/07/2024 and 02/09/2024. In this hearing of the appeal on 2nd day of September, 2024, Appellant present but PIO found absent, however he detailed his representative without proper authority letter. During the hearing the appellant has requested the Commission to dispose of the appeal case No. APIC-556/2023 filed against the PIO and he also stated the he wants to file a fresh RTI application before the concerned authority.
