## **ORDER**

This is an appeal filed under sub: section (3) of section 19 of the RTI Act 2005. Brief fact of the case is that the Appellants lebe Lamnio on 28/12/2023 filed ad RTI application under Forum 'A' before the PIO-cum EAC O/o the Deputy Commissioner, East Kameng, District, Govt of Arunahal Pradesh whereby seeking various information as quoted in Form-A application. The Appellants being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellant Authority (FAA) on 06/02/2024 the Appellants again having not received the required information(s) from the FAA, fled the Second Appeal before the Registry of the Commission (APIC) having receipt of the Appealregistered its as APIC No-151/2024 and proceed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thrice i.e 21/05/2024, 02/07/2024 and 22/08/2024. In this hearing of the appeal on 22<sup>nd</sup> day of August 2024. The Appellant Shri

Lamnio and the PIO found absent during the hearing.

However, the Appellant has submitted a letter to the Commission through whatsap on dated 22/08/2024 that he has received all the information (s) as sought in his Form'A' application and has requested the Commission for disposal /closure of his appeal on ground o f satisfactorily, this appeal stands dispose and closed once for all.
