**JUDGEMENT**

The 6<sup>th</sup> hearing held on **21<sup>st</sup> January , 2025** related to the **APIC No-93/2024** The PIO-cum-Under Secretary, RWD, Civil Secretariat, Itanagar, Govt. of Arunachal Pradesh, is present in person before the Commission, during the hearing and the Appellant Shri Tania June found absent without intimating to the Commission the reason for his inability to attend the hearing.

**Heard the PIO**

- (iii) The production of evidence by the PIO with a copy to the Commission that information(s) have been provided to the Appellant, convince the Commission that there is no scope to proceed on with further hearing.

**Therefore, the Commission order;**

In view of the above facts and circumstances, the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
