JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram , Adv. Lokam Tadam & Adv. Tap Sajan on **17/08/2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of Power, Naharlagun Division, P/Pare District , Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO. filed the First Appeal before the First Appellate Authority on **18.09.2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.12.2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 118/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 02.05.2024 & 06.06.2024. In this hearing of the appeal on 6th day of June, 2024. The Appellant Shri Riya Taram and the APIO present during the hearing.
