**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Takam Sakap on **24/05/2023** filed an RTI application in Form-'A' before the PIO-Cum-Executive Engineer, WRD, Palin Division District Kamle, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **27/06/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **3/07/2023** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 717/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thrice i.e on **03/12.2024, 03/12/& 13/02/2024** In this hearing of the appeal on 13<sup>th</sup> day of February, 2025, both the parties were absent during the hearing.

However, the Appellant has submitted a letter to the Commission on **10.02.2025**, stating that he has received all the information sought in his Form 'A' application from the PIO and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
