**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Balang Effa for non-furnishing of information by the PIO o/o the E.E, (RWD)(DPIU), Bameng Division, East Kameng district (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.07.2024.

The appellant herein had requested the PIO, o/o the Chief Engineer (RWD), Govt. of A.P, Itanagar to furnish the information on PMGSY Road and Vibrant Village Programme in East Kameng District. In response the APIO, o/o the Chief Engineer (PMGSY), Itanagar, vide letter dt.19.07.2024, forwarded the said RTI application to the Executive Engineer (RWD)(DPIU), Division Seppa / Chayang Tajo / Bameng, East Kameng District requesting the said Divisions to furnish the requested information to the applicant as the information falls within their jurisdiction.

This appeal under section 19(3) of the RTI Act was listed for 2 times earlier on 06.12.2024 and 17.01.2024. However, on both the dates the PIO did not appear while the appellant, Shri Balang Effa attended in person.

In today's hearing on 07.02.2025, Er. Shri Logo Rang, A.E -cum- APIO, o/o the Executive Engineer (RWD)(DPIU), Bameng Division and the appellant were present.

Heard both the parties.

The APIO submitted that he could not attend the last hearings because he received the copy of summon order late from the o/o the Ex. Engineer (RWD)(DPIU), Bameng Division through Whatsapp message. He, however, submitted that the documents requested for by the appellant in respect of roads under Vibrant Village Programme, leaving the toposheet which is not available with the PIO, shall be provided to him.

The appellant also submitted that he will be satisfied if he is provided with the copy of Sanction order and the road connection map under the Vibrant Village Programme in respect of Bameng and shall not press for the documents mentioned at Sl.(iv) and (v) of his application which are repetition of particulars at Sl.No. (ii) and (iii).

This Commission, after hearing the parties, directs the APIO/PIO o/o the Executive Engineer (RWD)(DPIU), Bameng Division to furnish the information as assured by the APIO and report compliance thereof to this Commission within 1(one) week from today.
