**ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Binny Alivish on **30.10.2023** filed an RTI application under Form-'A' before the PIO-Cum-O/o the Directorate of Department of Economics & Statistics, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **22.12.2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06.03.2024** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 144/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 09.05.2024 & 20.06.2024. In this hearing of the appeal on 20<sup>th</sup> day of June,2024. The representative of PIO Shri Tati Langdo, APIO present during the hearing but the Appellant Shri Binny Alvish found absent consecutively for two times i.e. on 09.05.2024 & 20.06.2024 without intimating the reason to the Commission for his inability to attend the hearing.

Heard the APIO.

The APIO stated before the Commission that the PIO has furnished all the information to the Appellant as sought in his form 'A' application, APIO also presented the receipt copy of the Appellant stating that he has got all the information from the PIO, as signed by himself, on dated 10.08.2023.

Upon the statement of the APIO and copy of the receipt letter of the Appellant, the Commission/Court presume that, this should be the reason that the Appellant is absent in the hearing for two times consecutively.

Whereas, the Commission sent an order on 14.05.2024 to the Appellant stating that, if he fails to appear in person or through online mode before the Commission during next hearing, his appeal shall be decided ex-parte.

In view of the above facts and circumstances, the Commission presumes that the Appellant has received all the information(s) from the PIO as sought in his application, which implies that he is no more interested in his appeal. Therefore, this Court/Commission find this appeal fit to be disposed off and closed, hence, this

Court/Commission does not find any reason for further hearing to be conduct. And, accordingly;

This appeal stands disposed off and closed once for all.
