ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Tamchi Gungte on 01/03/2023 filed an RTI application under Form-'A' before the PIO-Cum- BDO Tali,Kara Daadi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on <u>15.06.2023</u> the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on <u>26.07.2023</u> and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No.** 677/2023(Appeal), and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on dated 07/11/2024 & 19/12/2024. In this hearing of the appeal on 19th day of December, 2024. The Appellant Shri Tamchi Gungte present during the hearing but PIO absent during the hearing.

However, the Appellant Shri Tamchi Gungte has stated before the Commission, he received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
