JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dope Ori on **03.10.2023** filed an RTI application under Form-'A' before the PIO-cum-Junior Technical Officer, Department of SJETA, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01.11.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21/11/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1067/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on 29/05/2024 and 03/07/2024. In this hearing of the appeal on **3rd day of July, 2024**, both the parties present.

In the hearing the PIO has brought all the information as sought by the appellant and provided to him in the Court. The appellant has intimated to the Commission that he is satisfied with the information provided and requested the Commission to dispose off his appeal case No. **APIC 1067/2023** filed against the PIO-cum-JTO, Deptt. of SJETA.
