This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Sima, Khola Camp, Lower Bhalukpong, PO Bahlukpong, West Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DFO, Govt. of A.P. Dept. of Environment, Forest & Climate Change, Bomdila, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/03/2024 regarding **Implementation of Catchment Area Treatment for execution of Kameng HE Project (Cost of project: 129.00 crore).**

2). The 2nd hearing was held on 6th May' 2025 (Tuesday) at 1100 hrs. The PIO-Cum-DFO, Govt. of A.P. Deptt of Environment. Forest & Climate Change, Bomdila, West Kameng District, Arunachai Pradesh was represented by Shri Gollo Nema, LDC-Cum- APIO.

3). The representative of the PIO, stated that the remaining information as required by the Appellant as per Form "A" application has been furnished to the Appellant on the direction of the Commission on 18th April 2025 at 1100 hrs.

4). The Appellant Shri Tamchi Sima was absent, so could not be heard. During the 1st hearing the Commission had directed Appellant to collect the information from the office of the PIO and on receipt of the documents inform status report to the Commission within ten days. It was also clearly mentioned that if Appellant fails to appear in the next date of hearing the case shall be disposed of without any further notice. Hence, it is assumed that the appellant is satisfied with the information so furnished by the PIO.

5). Based on the verbal input given by the APIO, the Commission observes it fit to dispose of the case.
