The appellant file an RTI Application dated 19/07/2023 seeking Details regarding Chief Minister White Revolution Scheme entire Raga, Kamle District.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga on 01/07/2023 filed an RTI application under Form-'A' before the PIO-Cum-District Veterinary Officer, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 03/08/2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 04/09/2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 863/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1(one) time i.e on 11/11/2024. In this hearing of the appeal on 11th day of **November, 2024**, Appellants found absent without any intimation to the Commission and the PIO present before the Commission and submitted Affidavit on oath stating on declaration that no Chief Minister White Revolution Scheme was sanctioned in Kamle District as information sought by the appellant Shri Palen Laa & Smti Yukar Yaga. On the basis of the affidavit on oath submitted by the PIO, the Commission deems fit to dispose off the case as there is no such information available with the PIO in the Department of Animal Husbandry & Veterinary.

The appeal case No. APIC-863/2023 filed against the PIO-cum-DVO is disposed off in the absence of the appellant. And it is also to be noted that the appellant had already been provided the affidavit on declaration by the PIO and sent original. Certify copy of the affidavit submitted before the Commission in today and enclosed in the case record.
