JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Taba Tokur on **23/06/2023** filed an RTI application under Form-'A' before the PIO-Cum-Managing Director, Arunachal Pradesh State Co-operative Apex Bank Ltd, Naharlagun, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **14/08/2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **30/07/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 220/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 times i.e on **29/08/2024, 03/10/2024, 21/11/2024 and 30/01/2024** The **4th** hearing held on **30th January, 2025** related to the **APIC-No-220/2024**. The Appellant Shri Taba Tokur is absent without intimating the reason for his absence. The PIO-cum-MD, Arunachal Pradesh State Co-operative Apex Bank, Naharlagun, is represented by Shri Taba Oya (General Manager).

Heard the representative of the PIO:

The representative of the PIO stated that as per the direction of the Commission all information(s) sought by the Appellant have been furnished with seal and sign of the PIO on 23.10.2024 and the APIO exhibited the receipt of the Appellant Shri Taba Tokur.

The Commission observed:

The Commission is convinced with the receipt of the information(s) by the Appellant from the office of the PIO.

Under the facts and circumstances it is made clear to the Commission that the information(s) have been provided to the Appellant and the Appellant has received the information(s), and therefore, the Commission does not find reasons to extend further the hearing of this Appeal and with judicial mind dispose this Appeal with liberty given to the Appellant to file fresh application for the same information(s) if he needs to from the office of the PIO.

In view of the above facts and circumstances the Commission finds this Appeal fit to be disposed and closed. And, accordingly, this Appeal stands disposed and closed once for all.
