**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tana Roma Tara, for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, PWD, Basar Division, Leparada District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.11.2024.

**A) Particular of information:** (1) c/o road from Pagi to Malo under Basar, Leparada District (Rs. 1000.00 in cr.) under RIDF 2023-24  
(2) c/o CC pavement road at Soi Village to new settlement area (SOYA) at Basar (300.00 in cr.) under RIDF 2023-24.

**B) Details of information required:**

1. BoQ of CC pavement Road at Soi Village to New Settlement area (SOYA) at Basar as per NIT;
2. Technical Sanction order copies.
3. Contract agreement with competent Firms as per NITs.
4. Drawing of culverts & drains.
5. BoQ of road from Pagi to Molo under Basar, Leparada District as per NIT.
6. First and final bill statements & Bills abstracts.
7. Details of Bills transaction through PFMS/DBT/Cheque.

**C) Period for which information asked for: 2023-24**

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellant, Shri Tana Roma Tara had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Superintending Engineer (RWD), Basar, Leparada District, Govt. of Arunachal Pradesh, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 03.12.2024. However, the appellant failed yet again to obtain the information and therefore, he preferred his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act. 2005 vide his Memo of Appeal dt. 27.01.2025.

**Hearing and decision:**

This appeal was, accordingly, listed and heard on 30<sup>th</sup> April, 2025 wherein the PIO, Shri Karbom Basar, EE o/o the EE (RWD), Basar Division was present but the appellant Shri Tana Roma Tara was absent.

The PIO, who had brought in the requested documents in the hearing, submitted that in response to the RTI application submitted by the appellant, his office had readied the sought for documents and the appellant was informed on 22<sup>nd</sup> April, 2025 to remit requisite fees of Rs. 1200 (Rupees one thousand two hundred) only being the cost of documents but the appellant did not comply.

In absence of the appellant in the hearing, the documents brought in by the PIO could not be handed over to him. This Commission, therefore, directed the appellant to collect the sought for information from the Commission's office within one week and report to this commission about his satisfaction or otherwise failing which it was made clear that the appeal will be disposed of and closed presuming that he is not interested for the information and longer.

As directed, the appellant collected the documents today and after going through the same, has expressed in writing that he is satisfied with the documents so furnished by the PIO.

In the premises as above, this appeal stands disposed of and closed.
