JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Nabam Tai on 19/02/2024 filed an RTI application under Form- 'A' before the PIO-Cum- DFO, Khellong Forest Division, W/Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 19.03.2024 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 29.04.2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 187/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 11.06.2024. In this hearing of the appeal on 11th day of June, 2024. The Appellant Shri Nabam Tai & the representative of PIO Shri Tanga Murtem (RFO) were present during the hearing.

Heard both the parties.

The RFO stated before the Commission that the PIO has already intimated through a letter by the post office to the Appellant that the information sought by him is very voluminous to furnish and so, the PIO directed the Appellant to seek the information for one particular scheme or one block year for easy furnishing of the information.

The RFO also stated that the CCF-Cum- FAA, Banderdewa, already disposed off the appeal before his Court on dated 26.04.2024 thereby, the RFO produced before the Commission the order passed by the FAA and the intimation letter sent to the Appellant for minimizing the period of information as sought for a particular scheme.

The Commission after going through the documents produced by the RFO, ordered/ directed the PIO to furnish the information for one particular scheme or one block year every month for every year of information sought by the Appellant within 30 days of by passing this order and also directed to intimate the Appellant to collect the information by depositing the requisite fees. The

Appellant is also directed to collect the information from the PIO 's office by depositing the requisite fees.

Hence, the Commission find this appeal fit to be disposed off and closed and so, this appeal is disposed off.
