**ORDER**

The above appeals under Section 19 (3) of the RTI Act have been filed by Shri Tamchi Gungte, General Secretary, Arunachal Pradesh Peoples' Forum (APPRF) for non-furnishing of information by the PIO o/o the Executive Engineer WRD, Seppa East Kameng District.

In the appeal No. 678/2023 the appellant had requested for the 16 items of information regarding construction of Common Service Center (CSC) at Bana block (MCA) of East Kameng while in appeal No. 679/2023, the applicant had requested for information against 16 items regarding construction of Sadbhavna Mandap/ Bawan in Pakke Kessang block of East Kameng Dist.

The hearing of these two appeals was fixed on 2<sup>nd</sup> August and summons were accordingly issued to the parties concerned. However, in the mean time the appellant Shri Tamchi Gungte for the above appeals who is one and the same person visited the Commission Office today on 31 July 2024 at 03:30 PM and informed that the aforesaid appeals were actually disposed of already by the then Hon'ble Court of Ms. Sonam Yudron and that the two appeals have wrongly been listed for hearing in this Court.

As such the said Shri Tamchi Gungte pleaded this Commission to dispose of the above two appeal as withdrawn.
