JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act2005. Brief fact of the case is that the appellant Shri Riya Taramon 23.08.2022 filed an RTI application in Form-A to the PIO cum EE PHE & WS Bomdila Division West Kameng DistrictAP. whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum SE PHE & WS Circle Rupa West Kameng District A.P. on 25.10.2022.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 28.11.2022.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.767/2022 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 19.08.2024. Notice of hearing dated 02.07.2024 were served to FAA, PIO and the Appellant.

In this hearing of the appeal on 19.08.2024 the respondents PIO EE PHE & WS Bomdila Division West Kameng DistrictAPis absent. The appellant Shri Riya Taram appeared.

Heard the appellant.

The appellant has requested the Commission to close and dispose of this appeal case with written submission letter dated 3rd June 2024 as he has received complete and correct documents against his RTI application.
