**Information sought :**

The appellant file a RTI Application dated 02/06/2023 seeking Details regarding C/o Town double lane road at Pokriang SDO, Langrh & Phassang Circle and adjoining villages under NESIDS.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 11/07/2023. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Phassang Pada on 02.06.2023 filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 11.07.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 21.07.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 666/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 8 (eight) time i.e on 27/10/2023, 19/01/2024, 03/07/2024, 26/08/2024, 07/10/2024, 09/12/2024, 28/04/2025, 06/08/2025 and 01/09/2025. In this hearing of the appeal on 1<sup>st</sup> day of September, 2025, the PIO-cum-EE(PWD), Sangram Division, Kurung Kumey District and the appellant Shri Phassang Pada present in person.

After hearing both the parties, it is observed that all the documents sought by the appellant has already been provided as per the Form 'A' Application. There was some confusion regards to the documents provided from the appellant side but the PIO has cleared the confusion before the Commission today and the appellant is also satisfied.

If any additional information required by the appellant then he can file a fresh application before the PIO as per form 'A'. The appeal case is therefore, disposed of and closed today.


