

ARUNACHAL PRADESH INFORMATION COMMISSION, APIC ITANAGAR

An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-208/2024

(Or. 5, R.3 of CPC)

Shri Yomjum Nguba -V/S- PIO-cum- EE (WRD) Likabali Division, District Lower Siang

ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Yomjum Nguba on <u>08.12.2023</u> filed an RTI application under Form-'A' before the PIO-Cum- EE, WRD, Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on <u>08.02.2024</u> the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on <u>20.05.2024</u> and the Registry of the Commission (APIC), having receipt of the Appeal registered it as <u>APIC No. 208/2024</u> and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 25.07.2024 & 27.08.2024 In this hearing of the appeal on 27th day of August, 2024. The Appellant Shri Yomjum Nguba present during the hearing but the PIO found absent during the hearing.

However, the Appellant stated before the Commission that he has received all the information(s) as applied in his form 'A' application and submitted a letter to the Commission during the hearing for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
