JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Putum Kambu on 24.01.2023 filed an RTI application in Form-A to the PIO Cum PD (DRDA) Aalo West Siang Distt A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum DC Aalo West Siang District A.P on 28.02.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 11.04.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.297/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 6th hearing before the Commission Court today on 29.08.2024. Notice of hearing dated 05.08.2024 were served to PIO and the Appellant.

Both the appellant and the PIO did not appear.

The appellant has requested the Commission to close and dispose of this appeal case with written submission letter dated 22<sup>nd</sup> July 2024 as he has received complete and correct documents from PIO Cum PD (DRDA) Aalo West Siang Distt. against his RTI application and he is fully satisfied with it.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.
