**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tarh Atung on **22/08/2023** filed an RTI application under Form-‘A’ before the PIO-cum-Higher and Technical Education, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **27/09/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06/10/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 975/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (six) times i.e on 18/12/2023, 20/12/2023, 29/01/2024, 10/04/2024, 12/06/2024 and 31/07/2024. In this hearing of the appeal on 31<sup>st</sup> day of July, 2024, both the parties present. During the hearing, the PIO has brought the information as sought by the appellant and handed over same to the appellant before the Commission. After going through the documents provided, the appellant has stated that the documents/information sought by him of Income Certificate is not available in the document furnished to him and asked for the said document from the PIO.

The PIO has also stated that no such document of Income Certificate is available and he is ready to file declaration through Affidavit. Therefore, the PIO is directed to provide declaration of Affidavit to the appellant within 10(ten) days from today and appellant is also directed to submit copy of the declaration to the Commission.
