JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **06/07/2023** filed an RTI application under Form-‘A’ before the PIO-cum-Executive Engineer (RWD) Bameng Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **08/08/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 909/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (six) times i.e on 13/11/2023, 18/12/2023, 19/01/2024, 27/03/2024, 05/06/2024 and 29/07/2024. In this hearing of the appeal on 29th day of July, 2024, appellant present but PIO found absent. However, the appellant has intimated to the Commission that all the information as sought by him has been furnished by PIO and is satisfied with the information provided.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
