JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Takam Sakap on **14/03/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (UD & Housing), Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **18/04/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19/05/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 489/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 10 (ten) times i.e on 29/06/2023, 10/08/2023, 04/10/2023, 13/11/2023, 18/12/2023, 19/01/2024, 27/03/2024, 05/06/2024, 29/07/2024 and 02/09/2024. In this hearing of the appeal on 2nd day of September, 2024, PIO-cum-EE (UD & Housing) Koloriang present in the hearing but the appellant found absent, however appellant Shri Takam Sakap has submitted a letter addressed to the SIC with a request to dispose of the appeal case No. APIC-489/2023 filed against the PIO-cum-EE (UD & Housing), Koloriang. It is mentioned here that he has got all the information sought by him from the PIO and he is satisfied with the information provided.
