**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Bida Hina on **30/06/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PHED & WS) Sagalee, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21/08/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16/10/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 995/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) times i.e on 18/12/2023, 19/01/2024, 27/03/2024, 05/06/2024 and 29/07/2024. In this hearing of the appeal on 29<sup>th</sup> day of July, 2024, both the parties were present and the PIO has stated that the additional documents as sought by the appellant has already been furnished to the appellant and submitted a copy of forwarding letter before the Commission. The appellant has also agreed with the PIO's statement.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
