The appellant file an RTI Application dated 11/09/2023 seeking Details regarding expenditure & implementation of under united fund and NON-BDF sanction order/complete of work order.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tap Sajan on **11/09/2023** filed an RTI application under Form-'A' before the PIO-Cum-Block Development Officer, CD Block, Chetam, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07/11/2023**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22/12/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1188/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6(six) time i.e on **26/06/2024, 21/08/2024, 07/10/2024, 02/12/2024, 13/01/2025** and **24/02/2025**. In this hearing of the appeal on **24th** day of February, 2025, the PIO-cum-DPO, Raga, Kamle District found absent and the appellant ShrinTap Sajan present in person.

On the last hearing dated **13/01/2025** the representative of the appellant has stated before the commission that all the documents as sought by the appellant has been kept ready to provide to the appellant but the appellant did not turned up. He also stated that the appellant wants to close the case on receipt of the documents.

Today on **6th** hearing dated **24/02/2025**, the appellant present and requested the Commission to dispose off the appeal case No. APIC- 1188/2023. Accordingly, this appeal case is disposed off and closed once for all.
