**ORDER**

This was a Complaint case under Section 18(1) of RTI Act, 2005 filed by Shri Tania June & Shri Issac Ejing for denial of information by the PIO, o/o the Executive Engineer, PHED Division, Yingkiong, Upper Siang District(A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 05.11.2024.

The complainant herein had requested the PIO for the above mentioned information but the PIO rejected their application vide Form-C dt.03.12.2024 on the ground that their application fee was not through the Treasury Challan and also that the information sought for is not specific, among others.

Aggrieved by the response of the PIO as above, the complainants filed this complaint under section 18 of the RTI Act, 2005 which was registered as APIC-14/2024 and listed for hearing on 14.02.2024 wherein the complainants, Shri Tania June and Issac Ejing are present but the PIO were absent.

This Commission heard the appellants who demanded that stern action should be taken against the PIO concerned for rejecting their application illegally without knowing the correct provisions of law. However, in the absence of the PIO in the hearing, this Commission could not hear him. But since the primary request of the complainants/appellants was to obtain the information, this Commission, after explaining the provisions of section 18 and section 19 of the RTI Act to the complainants/appellants, the Complaint was converted into appeal and summoned the PIO for hearing in the next date which was fixed on 07.03.2025 wherein the PIO, the Executive Engineer, PHED, Yingkiong Division, Upper Siang District (A.P) was directed to be present in person or depute his APIO failing which necessary action under section 20 of the RTI shall be initiated for violation of the provisions of RTI Act 2005.

In the hearing listed on 07.03.2025, both the complainants /appellants and the PIO were absent but the PIO vide his letter dt.04.03.2025 intimated this Commission that due to his pre-occupation in the local festival being held from 7<sup>th</sup> to 9<sup>th</sup>March, 2025, he will not be able to attend the hearing.

This case was, therefore, adjourned to 21.03.2025 with the warning that if the parties, particularly the complainants/appellants fail to attend the hearing on that date the case shall be closed as not being pressed for adjudication.

In the hearing fixed today on 21.03.2025, both the parties again failed to attend the hearing without any intimation. Therefore, in terms of the warning contained in the order dt.07.03.2025, this Appeal stands closed as not being interested and pressed by the appellants for further adjudication by this Commission.
