Decision:

The commission after adverting to the facts and circumstances of the case, and perusal of the records, observes that the appellant has not complied the

Commission's Order dated 20.10.2023 and 12.01.2024. In the interim order dated 20.10.2023 the appellant was directed to file a written submission to the PIO on or before 12.01.2024 after examining the information furnished to him, failing which the appeal case shall be disposed of. Again, in the order dated 12.01.2024 the appellant was directed to verify the information and file written submission to the PIO within 3 weeks. Irrespective of orders issued by the commission the appellant has not complained about the information already received by him. Hence, I find it a fit case to be close and dispose of.

This appeal case is disposed of accordingly at Commission.
