ORDER

- 1) This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Yiter Lombi & Yidik Lombi, Library Guwahati High Court, Itanagar Permanent Bench, Naharlagun Arunachal Pradesh for non-furnishing of information by the PIO-cum-Project director, DRDA, Leparada District, Govt. of Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/11/2022 regarding Pradhan Mantri Awaas Yojana (PMAY-G) Under Basar, Leparada District.
- 2) The 9th hearing was held on 24th September, 2024 as scheduled. Shri Ejum Angu, the PIO-cum-Project director, DRDA, Basar, Leparada District, Govt. of Arunachal Pradesh was represented by Er. Toli Gamlin, APIO-cum-APO (RE), RD, Basar, Leparada District. The Appellant shri Yiter Lombi was found absent.
- 3) The APIO had submitted that all the relevant information have already been furnished and received by the Appellant. The site inspection of projects as requested by the Appellant had also been facilitated and site inspections carried out through concern BDOs. The APIO produced documentary evidences against his submissions.
- 4) The Commission after going through the document observed that the information as sought for by the Appellant in Form-A Dated 12/11/2022 had been furnished by the PIO-cum-Project Director, DRDA, Leparada District, vide letter No. DRDA/BSR/RTI/2022023. So request placed for information at Sl.no. 5, 9, 11 & 12 is not understood. As per the request of the Appellant, the PIO facilitated site inspection vide letter No. DRDA/BSR/RTI/2024-25 Dated the Basar 20th June, 2024 and it is informed that site inspections were completed through concerned BDOs.

- 5) The absence of the Appellant without proper intimation to the Commission was viewed seriously and the Commission, giving reasonable opportunity, had directed the Appellant to revert to the Commission within one week from the issue of the Order Dated 24th September, 2024 with authentic documentary evidences for his absence from the court hearing. Caution was given that failing which the case shall be treated as closed and dispose of the same. Till date the Appellant has not responded to the Commission's warning.
- 6) The Commission in view of above decides to close and disposed of the case.
- 7) Therefore the case is hereby closed and disposed of.
