ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on 20.01.2023 filed an RTI application in Form-A to the PIO cum BDO, Aalo CD Block, West Siang District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum Director, RD Itanagar, Papumpare District Govt. of AP on 29.03.2023.

Appellant again having not received the required adequate information on decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 15.05.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.426/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 09.09.2024. Notice of hearing dated 12.08.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 09.09.2024 the respondents PIO Smti. Dongam Nyodu BDO Aalo CD Block West Siang District is present & the FAA cum Director RD, is represented by Ms. Tongyang Annu (APIO). The appellant Shri Tania June appeared.

Heard the parties present.

PIO states that she has furnished the information documents by registered speed post to the appellant.

The appellant states that he has received the information sent by the PIO in full shape and satisfied with it. So, he has requested to close this appeal case.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.


