JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Riya Taram on **18/8/2023** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (Power) Longding Division. District Longding, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **19/9/2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **02.04.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 100/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for fifth times i.e on **07/05/2024, 06/06/2024, 06/08/2024, 21/02/2025 & 08/04/2025 25.07.2024**. In this hearing of the appeal on 8th day of April'2025. Both the parties were present during the hearing in person.

However, the Appellant has submitted a letter to the Commission by hand, stating that he has received all the information as sought in his Form 'A' application and therefore has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above submission of the Appellant and relying on the facts and circumstances of the case, the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
