Information sought :

The appellant file a RTI Application dated 07/09/2024 seeking Details regarding (i) Integrated large scale Eri Farming Project under NERTPS etc. at East Siang District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 01/11/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Miss Bengia Mama present in person.
Respondent : PIO-cum-Asstt. Director (T &H), Psg, present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mamu on **07.09.2024** filed an RTI application under Form-'A' before the PIO-cum-Assistant Director, Textile & Handicraft, Pasighat, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **01.12.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 415/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 12/03/2025. In this hearing of the appeal on 12th day of March, 2025, both the parties, PIO-cum-Assstt. Director, Textile & Handicraft, Pasighat and Miss Bengia Mama present in person. On the hearing, the PIO has stated before the Commission today that information sought by the appellant for the year from 2018-2024 has been provided to the appellant and copy of the forwarding letter enclosed.

The appellant has stated that the information sought at his Form 'A' application Sl. No. 12, 18 & 20 has not been furnished and some of the Geotag photograph are not given in full. But the PIO stated that regarding the Geotag no proper instruction has been given by the Director. Regarding the Sl. No. 12, 18 and 20 there is no such information available with the PIO.

Considering the submission made by the PIO, as rest of the information are available in the Director level the appellant is on liberty to file his application for seeking rest of the information from the Director level. After heard both the parties the appeal case No. 415/2024 disposed off and closed.
