**JUDGMENT/ORDER**


This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram on **17/04/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17/05/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **20/06/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 563/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 8 (eight) times i.e on 18/09/2023, 06/11/2023, 18/12/2023, 19/01/2024, 27/03/2024, 05/06/2024, 29/07/2024 and 02/09/2024. In this hearing of the appeal on 8<sup>th</sup> hearing dated 02/09/2024, PIO attended through online mode but appellant found absent without any intimation to the Commission.

As per the order dated 5/6/2024 6<sup>th</sup> hearing, the documents as sought by the appellant was brought before the Commission to hand over to the appellant. The appellant was directed to collect the documents from the PIO and intimate the Commission.

On 7<sup>th</sup> hearing on dated 29/7/2024, appellant was directed to intimate the Commission regarding the documents received. Today on 8<sup>th</sup> hearing on dated 02/09/2024, PIO-cum-Executive Engineer (PWD), Bomdila Division, West Kameng District intimated to the Commission that documents sought by the appellant has already been handed over to the appellant on 6<sup>th</sup> hearing on dated 5/6/2024.

The Commission deems that the appellant is satisfied by the documents provided to him by the department. The Commission deemed fit to dispose off case today in the absence of the appellant.
