- i. Please provide me the certified true copies of the Arunachal Pradesh Stone Crusher Guidelines 2012 which was published in the Arunachal Pradesh Gazette Notification dated 15/01/2013.
- ii. Please provide me the certified true copies and the details of total numbers of stone crusher unit established and running at Liru, Siji and Magi village area and further please specify the details of the name of persons/firms/companies in favor of whom No Objection Certificate has been issued from the office of the Secretary, Geology and Mining, Itanagar for the establishment and running of stone crusher unit at Liru, Siji and Magi village area.
- iii. please provide me the certified true copies and details of the application filed by all the persons/firm/companies of stone crusher unit established and running at Liru, Si) & Magi village area in CU Form-A before the Secretary (Geology and Mining) Itanagar through office of the deputy Commissioner, Lower Siang District, Likabali, Arunachal Pradesh.
- iv. Please provide me the certified true copies and details of the Detad Project Report (OPR) of each stone crusher unit established/installed and running at Liru, Siji & Magi village area which was submitted by each person's/firms/companies while submitting the CU Form-A before the Secretary (Geology & Mining), Itanagar for obtaining of NOC and further please specify whether the said OPR's were verified and approved by the concerned Assistant Mineral Development Officer (AMDO) and Deputy Director of industries.

Further please provide the details of specifications of the Stone Crusher Machine permitted to be installed by the Government of Arunachal Pradesh to each of the person's/firms/companies running stone crusher unit at Liru, Siji and Magi village.
- ix. Please provide me the certified true copies and details of the minimum distance criteria for the stone crusher pliant from village/human habitation.
- x. Please provide me the certified true copies and details of the minimum distance criteria for the stone crusher plant from river lake/stream.

xi. Please provide me the certified true copies and details of the minimum distance criteria for the stone crusher plant from national/state highway (from centre line).

xii. Please provide me the certified true copies and details of the minimum distance criteria for the stone crusher plant from wildlife sanctuary/reserve forest.

xiii. Please provide me the certified true copies of the NOC issued to the persons/films/companies of each stone crusher unit from the office of the Divisional Forest Officer, Likabali, Lower Siang District, Arunachal Pradesh

xiv. Please provide me the certified true copies of the NOC issued to the persons/firms/companies of each stone crusher unit from the office of the Circle Officer/Extra Assistant Commissioner, Likabali,: Lower Siang District, Arunachal Pradesh

xxiii. Please provide the certified true copies and details of the standard operating procedures (SOP) to be followed by the persons/firms/companies of the stone crusher unit in order to control the air pollution.

xxiv. Please provide the certified true copies and details of the name of the persons/firms/companies who have obtained mining lease/ minor mineral lease or permit from the Department of Geology and Mining, Government of Arunachal

Pradesh, Itanagar for carrying out mining activities within the Liru, Siji and Magi village of Lower Siang District Arunachal Pradesh.
