This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tania June for non-furnishing of information by the PIO, o/o the DMO, Papum Pare District, Yupia,(A.P) as sought for by him under section 6 (1) (Form-A) of RTI Act, 2005 vide his application dated 07.10.2023.

The Appellant Shri Tania June, vide his application dated 07/10/23 had requested for 7-point information(s) regarding appointment of Field Workers/Regular Field Workers/Supervisor Field Workers/ANM under DMO, Papum Pare District.

Having failed to receive the sought for information from the PIO, the Appellant had preferred First Appeal before the Deputy Commissioner Papum Pare -cum- First Appellate Authority (F.A.A), vide his appeal dated 05/12/23 but having failed yet again to obtain the information, the Applicant/Appellant preferred Second Appeal before this Commission vide Appeal Memo dated 31/01/24.

This Appeal was accordingly listed for hearing on 20/11/24 and issued Summon notice dated 22/10/24 to the parties.

However, in the meanwhile the Applicant/Appellant Shri Tania June, vide his letter dated 29/10/24 addressed to this Commission and sent through WhatsApp, has informed that he has received all the information(s) as sought by him from the PIO, o/o the DMO, Papum Pare District, Yupia of which he is satisfied and accordingly requested for dispose and closure of this Appeal No. APIC-81/24.
