ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Dongru Tania for non-furnishing of below mentioned information by the PIO, o/o the Deputy Director of School Education, Govt. of Arunachal Pradesh, Changlang, District Changlang as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.09.2024

(A)Particular of information

: Recruitment and appointment of TGT/ PRT Teacher / UDC/LDC/ peon/ All MTS Posts.

(B) Details of information required:

- 7.CCTV footage during walk-in-interview held (Xerox copy);
- 8. Number of candidates appeared in exam applied for the post (Xerox copy);
- 9. Qualified list of candidates (Xerox copy);
- 10. The names of appointing authority (Xerox copy);
- 11. Appointment order (Xerox copy);
- 12. Calling letter (Xerox copy);
- 13. Departmental Promotion Committee (Xerox copy);
- 14. Seniority list (Xerox copy);
- 15. Educational qualification certificate (Xerox copy);
- 16. The written examination mark sheet (Xerox copy);
- 17. Viva-voce test (Xerox copy) and
- 18. The Govt. recruitment notification order (Xerox copy)

Facts emerging from the appeal:

The appellant, Shri Dongru Tania, vide his application dated 07.09.2024, had requested the PIO, o/o the Deputy Director of School Education, Govt. of Arunachal Pradesh, Changlang for the abovementioned documents. But the PIO did not furnish the sought for information within the stipulated period which prompted him to file his First Appeal under section 19(1) of the RTI Act before the 1st Appellate Authority (FAA), the Director, Elementary Education, Govt. of A.P, Itanagar vide his Memo of Appeal dt.21.10.2024, which, as per the tracking record of the Speed Post, was delivered to the o/o the FAA on 22.10.2024. But the appellant, yet again failed to obtain the sought for information.

Hearing and decision:

Hence, this 2nd appeal before this Commission under section 19(3) of the RTIA vide Memo of Appeal dt.29.11.2024 which was, accordingly, listed for hearing on 21.02.2025 wherein the appellant, Shri Dongru Tania and Shri Linko Tara, BEO-cum-APIO, o/o the DDSE, Changlang were present in person.

The APIO, Shri Liko Tara brought the sought for information/ documents which was handed over to the appellant during the hearing.

This Commission, upon perusal of the documents brought in the APIO, observed that against 4(four) points at Sl.No.6 (official website), Sl.No.7(CCTV footage), Sl.No.12(calling letters) and Sl.No.13 (DPC), it has been remarked as "N/A". When asked as to whether the "N/A" stands for 'Not Available' or 'Not Applicable', the APIO replied that it stands for 'Not Available'.

In order that such confusion is removed, this Commission directed the APIO to furnish specific replies to those points as to whether or not they are available with the o/o the PIO and if not available then an affidavit to that effect with cogent reasons thereof be furnished within a period of two weeks from 21.02.2025. The appellant was also directed to go through the documents so received and report his satisfaction or otherwise to this Commission within 2(two) weeks so that the next date of hearing, if required, could be fixed and intimated to the parties.

This Commission is now in receipt of letter dt.18.03.2025 from the appellant, Shri Dongru Tania intimating that he has received all the information as sought for by him and that he is satisfied with the documents he so received. He, therefore, requested this Commission to dispose of and close this appeal case No.APIC-383/2024.

In the premises as above, this appeal stands disposed of and closed.
