ORDER

- 1. This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri YiterLombi, Library Guwahati High Court Permanent Bench Itanagar for non-furnishing of information by the SPIO-cum-EE(PWD) Govt. of A.P. Basar Division, Leparada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/11/2022 regarding c/o Power Block Surface Road and Bituminous Concrete road at Bam village, Leparada District (L-0.56 km (old Bam & Lipu Bam).
- 2. The 8th hearing was held on 24th September, 2024 as scheduled. The PIO-cum-EE (PWD) Govt. of A.P.Basar Division, Leparada District, Arunachal Pradesh and the Appellant Shri Yiter Lombi were found absent.
- **3.** The PIO, vide letter No. BD/E-52/2023-24 Dated 23/06/2023 claims to have tried to furnish information before the Court of 1st Appellate Authority but the Appellant failed to appear during the hearing. So, the Appellant was asked to collect information from the office of the PIO. Further, the PIO claims that information were furnished to the Appellant vide letter No. BD/E-52/2022-23/892 Dated 07/03/2023 and BD/E-52/2023-24/41 Dated 03/05/2023. The PIO in support of his claim has submitted copies of the same to the Commission.
- **4.** The Commission on scrutiny of the case observes that the PIO has diligently tried to furnish information to the Appellant. In case the next date of hearing is fixed the PIO-cum-EE (PWD) Govt. of A.P. Basar Division, Leparada District, Arunachal Pradesh must be present before the Commission's Court without fail with all the relevant document in support of action taken.
- 5. The absence of the Appellant without proper intimation to the Commission is viewed seriously. The Commission, giving reasonable opportunity, directs the Appellant to revert to the Commission within one week with authentic documentary evidences for his absence from the court hearing, failing which the case shall be treated as closed and disposed of.
