## ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act. 2005. Brief fact of the case is that the appellant Shri Mamu Sonu on 17.02.2023 filed an RTI application in Form-A to the PIO cum EE IMC Part- I Chimpu Itanagar Papumpare District A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum Commissioner IMC, Itanagar AP on 10.03.2023.

Appellant again having not received the required information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 17.04.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.319/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 19.08.2024. Notice of hearing dated 28.06.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 19.08.2024 the PIO and Appellant did not appear.

On perusal of this appeal case record it is found that, in the  $1^{st}$  hearing dated 29.09.2023 PIO absent and Appellant is present. The PIO was directed to furnish information within three weeks. In the  $2^{nd}$  hearing dated 18.12.2023 both PIO and Appellant absent. In the  $3^{rd}$  hearing dated 05.04.2024 both PIO and appellant absent.

And today in the 4<sup>th</sup> hearing both PIO & appellant are again absent. If the PIO & appellant remain absent in the next hearing then ex parte decision of this appeal will be taken and disposed of.

Next date of hearing shall be fixed in due course of time.
