- i. Furnish a copy of the amount released by the Govt. of India, Ministry of Agriculture and welfare Department of Agriculture and farmers welfare for the State of Arunachal Pradesh under the above PMKSY Scheme.

- ii. Furnish the details of the total Fund/ budget allocation for 3 years i.e. from 2015-2018 under the scheme, PMKSY for the entire district of Arunachal Pradesh.
- iii. Furnish the details of the total fund/ budget allocation for the year 2019-2022 under the scheme, PMKSY for the entire district of Arunachal Pradesh.
- iv. Furnish a copy of the annual action plan for PMKSY for the State of Arunachal Pradesh with budget allocation till now (i.e. 2015- 2022)
- v. Furnish the details of the place of implementation of such scheme or the name of the locations of PMKSY clusters and areas.
- vi. Furnish a copy of the digital photography or blueprint of the location where the scheme has been implemented along with Geo-Tagging bearing latitude & longitude. (Geo-Tag report)
- vii. Furnish a copy of the completion Report/ certificate by all District Agriculture Offices (DAO) or Head of the concerned Authorize Department of the years 2015-2016-2017-2018-2019-2020-2021-2021.
- viii. Furnish the list of entire beneficiaries.
- ix. Furnish year wise Utilization Certificate (UC).
- x. Furnish copies of completion report.
- xi. Furnish the details of procurement of items for irrigation, name of the firm/ shops/ dealers/ along with the invoice.
- xii. Furnish the details of payment made of procurement of items for soil irrigation.
- xiii. Furnish the list of suppliers of such schemes in the state.
- xiv. Furnish the list of suppliers of each district.
- xv. Furnish the details of structures built if any. If not, furnish the details.
- xvi. Furnish the details of items procured for soil irrigation.
